### Peoria Ballet COVID-19 Consent Form

I, the undersigned parent or legal guardian, knowingly and willingly consent to have my child participate in programs at Peoria Ballet during the global COVID-19 pandemic. I understand the COVID-19 virus has a long incubation period during which time carriers of the virus may not show symptoms but still be highly contagious. I understand and agree to the following:

1. I acknowledge and fully understand that my child cannot participate in any activities if my child has recently suffered from and/or been exposed to someone in the past 14 days with any of the following:

- Fever
- Shortness of breath
- Cough or any flu like symptoms including GI upset, headache, fatigue
- Sore throat
- Recent loss of taste or smell

2. An inherent risk of exposure to COVID-19 exists in any public place where people are present, which will include the Peoria Ballet facilities. I agree to and do hereby assume all risks and accept personal responsibility for any damages and the risks related to exposure to COVID-19. I will hold harmless and indemnify Peoria Ballet and its teachers, associates, employees, clients, customers, agents, affiliates, successors, assigns, legal representatives, sponsors, and supervisors, against any claims and/or actions related to or arising from COVID-19 or any other transmissible contagion or disease, in exchange for being allowed to participate in studio programs at Peoria Ballet during this Covid-19 pandemic.

3. I agree that my child will abide by the following procedures and protocols, as well as any additional directives provided by Peoria Ballet faculty and staff:

- Class size maximum: Will follow directives by the State of Illinois and Restore Illinois.
- Students will maintain social distance of 6 feet at the barre and when working in the center.
- Studio is open to students only. Parents and siblings are not permitted in the building. Please drop off & pick up students at the front door.
- Students & faculty will have a temperature check & screening for COVID-19 symptoms upon entering the building. Hand sanitizer will be used upon entering the building and immediately after class. Parents will not depart from the parking lot until their child has indicated that she or he has passed the temperature check and screening.
- Face masks/coverings are required in the common areas of the building. Students may take off their masks in the studio during class, after which they shall maintain a distance of at least six feet from others.
- Students may arrive 10 minutes prior to class and must be picked up promptly at the end of class.
- No public drinking fountain or use of refrigerator will be allowed. Students must bring their own water.
- Locker Rooms will be closed – students should proceed directly to the studio upon entering the building.

Peoria Ballet will continue to update safety procedures as new directives become available from relevant authorities including the Centers for Disease Control and Prevention (CDC) and the State of Illinois. Peoria Ballet is committed to cleaning and disinfecting the studios, bathrooms, and lobby in compliance with CDC protocols.

I have read the above Waiver and Release and understand that by signing below, I have given up substantial rights on behalf of myself and my child. I agree that if, in the sole and unreviewable determination of the Peoria Ballet, I or my child fails to abide by the foregoing in any way, the Peoria Ballet may summarily revoke my child's ability to participate in-studio and I shall have no right or recourse to a refund.
